Kushner on Trump's Israeli-Palestinian **Initiative: 'We Want to Bring Peace, Not Fear'**

White House senior adviser Jared Kushner spoke publicly on Monday for the first time on the details of the Trump administration's yet-to-be-unveiled Israeli-Palestinian peace plan.

In an interview with Sky News Arabia, President Donald Trump's son-in-law, who was put in charge of the Israeli-Palestinian file, said,

"We want to bring peace, not fear." Kushner described the plan as "very detailed," touching on all aspects of the conflict, including the "redrawing of boundaries and resolving final status issues."

Noting that "very little has changed over the last 25 years," Kushner said the plan sought to "formulate realistic solutions for the issues of 2019, which will improve quality of life."

The plan would "have a broad economic impact, not only on Israel and the Palestinians, but on the entire region as well," Kushner asserted. "We want to ensure there is free flow of people and of goods. We must create new opportunities."

Noting the intra-Palestinian political divides - with the Palestinian Authority in charge in parts of the West Bank and Hamas ruling the Gaza Strip - Kushner stated, "We want to see the Palestinians united under one leadership, the Palestinians want a non-corrupt government that cares for their own interests."



Pressure Over Iran Nuclear Deal Forced Zarif to Resign, Ally Says

Pressure from hardliners over Iran's nuclear deal with world powers forced Foreign Minister Mohammad Javad Zarif to resign, an ally said on Tuesday.

Zarif - the US-educated architect of the 2015 pact which curbed Iran's nuclear program in exchange for sanctions relief - gave no reason when he announced his decision on Monday, news which sent Iranian stocks lower.

"There were closed-door meetings every week, where top officials were bombarding him with questions about the deal and what will happen next and so on," the ally told Reuters on condition of anonymity.

"He and his boss (President Hassan Rouhani) were under huge amount of pressure," the ally added.

Anti-Western factions in Iran criticized Rouhani and Zarif after the US pulled out of the nuclear agreement last May and reimposed sanctions on Iran's economy and its lifeblood oil industry that were lifted under the deal.

Abbas' Popularity Alters Israel's Political Landscape



It was a rough week for Israeli Prime Minister Benjamin Netanyahu. He saw his main opponents join forces, and the Blue and White Party that resulted from this merger surpassed Netanyahu's Likud Party in the polls. If that wasn't enough, Netanyahu's decision to encourage one of his coalition partners to take in a party whose leaders are followers of the late Rabbi Meir Kahane set off a storm of criticism from Jews who felt that Netanyahu was wrong to help legitimize an extremist group.

But while Netanyahu has been taking it on the chin, the man that much of the world still imagines is Israel's peace partner seems to have had a very good week. And the explanation for that unexpected development is the reason why Netanyahu's prospects for holding on to his office are not quite as gloomy as his detractors may think.

Palestinian Authority (PA) leader Mahmoud Abbas is currently serving the 15th year of his four-year term as president of the PA (he was elected in January 2005). He is widely reviled by most of those whom he pretends to serve. He remains opposed to negotiating peace with Israel. The kleptocracy over which the 83-year-old presides is a disgrace. He refuses to make peace with Israel, but is also dependent on security cooperation with the Jewish state.

But Abbas' popularity is suddenly soaring. In the last year, both the United States and Israel have enacted measures to cut back on cash flowing to his regime in order to force him to end the practice of rewarding those who attack, wound, and kill Israelis, Jews, and Americans with salaries and pensions.Last week, Israel tried to force Abbas' hand on the issue of his pay-toslay policy by deducting some \$138 million from the tax revenue that it collects and then transfers to the PA. But the Palestinian leader refused to budge. To the contrary, he vowed never to accept a single penny of the money that Israel hands over to his government so long as any of it was held back.

In theory, this ought to have generated a revolt from ordinary Palestinians, who shouldn't want the minimal services that the PA performs for them to be impacted for the sake of terrorists. But it has had the opposite effect.

Palestinian social media is buzzing with praise for Abbas' stand. Outside of Gaza, whose people are being starved and squeezed by Abbas' efforts to pressure his Hamas rivals who govern the Strip, there's every sign that his stand is widely applauded by most Palestinians who agree with his decision to keep funding "martyrs."

To some extent, this is a familiar game of "chicken" that Israel's government and Abbas have been playing for years. Neither Netanyahu nor Abbas wants to abandon the security cooperation that both keeps a lid on terrorism (if not eradicating it) and protects the PA leader and his cronies from Hamas. Israel doesn't want the PA to collapse, which would force it to directly rule the Palestinians in the West Bank, and Abbas and the rest of his corrupt gang that profits from his rule don't want the flow of cash to their families and foreign bank accounts to cease.

But however this standoff is resolved, it goes a long way toward explaining what's been happening prior to the Israel's April elections. Netanyahu is facing potential political

doom because, unlike the last three elections that he won, he isn't facing off against an opponent that is easily labeled as a "leftist" willing to make concessions to the Palestinians in the vain hope of peace. The Israeli left has been marginalized. Instead of a party of peace advocates that can be pilloried for their naïveté, the alternative to Likud is a party led by a trio of former generals.

Netanyahu and his allies are accusing the Blue and White Party — and its leader, Benny Gantz — of being leftist peaceniks flying under false centrist colors. Maybe there's some truth to that argument, as Gantz will likely have to ally himself to the left in order to form a government. But since it counts among its leaders figures like former Defense Minister Moshe Ya'alon, who is arguably to the right of Netanyahu, that charge may not stick. Whatever you may think of the new party, its rise, coupled with the collapse of the left, stands as testimony to the post-Oslo sea change in Israeli politics.

Who created that change? For all his tactical cleverness and sure governing skills,

it wasn't Netanyahu. The person who ensured that the Israeli public would draw conclusions from the last 25 years, and essentially give up on the notion of the Palestinian Authority as a peace partner, is none other than Abbas. Had he really been different from his terrorist predecessor, longtime PLO chief Yasser Arafat, it's conceivable that Netanyahu might have been in the opposition during the last decade.

But by sticking to the language of conflict with Israel and Zionism that is inextricably tied to the sense of Palestinian national identity that Arafat and Abbas fostered, the PA has ensured that most Israelis have stopped believing that peace is an option in the foreseeable future. Gantz is giving Netanyahu a run for his money because much of the Israeli public sees no real difference between their stands on the peace process. If, after staying too long in office, Netanyahu still has a decent chance of leading the next government, it's because a critical mass of Israelis think the coalition of parties of the center and *Continued on Page A12*

New York Times Issues Correction to Front-Page Attack on Netanyahu



The New York Times has already issued a correction to its latest front-page attack on Israel's prime minister, Benjamin Netanyahu.

"An earlier version of this article misidentified Moshe Kahlon, a member of Benjamin Netanyahu's government. He is the finance minister, not the foreign minister," the correction says.

If the *Times* is candid with its readers — a big "if" — it'll be the first of several corrections eventually appended to the article.

The *Times* writes, "The pact between Mr. Netanyahu and the Kahanists set off a predictable eruption from liberal Jewish groups like J Street and Americans for Peace, as well as the Union of Reform Judaism, which normally stays out of Israeli politics."

The correct name of the group the *Times* is referring to is not "Americans for Peace" but "Americans for Peace Now."

The *Times* also writes, "In Israel's chaotic parliamentary system, small parties like the ultra-Orthodox Shas can be make or break when it comes to forming a majority coalition after an election, and Mr. Netanyahu has routinely struck deals giving them outsize influence."

Shas has declined in recent years, but for the purpose of general historical context such

as the Times is attempting to provide, it is not a "small" party. In 2013 it won 8.75 percent of the vote, enough for 11 seats in Israel's parliament. In 1999 it was the third largest political party in Israel, winning 13 percent of the vote and 17 seats in the 120-member Knesset, drawing not only "ultra-Orthodox" voters. In 1999, the politician who struck a coalition deal with Shas wasn't Netanyahu but rather Ehud Barak of the Labor Party. This may seem like a minor detail, but it undermines the point of the Times article, which is that Netanvahu caters to extremists or fringe elements in Israeli politics. It's not a characteristic unique to Netanyahu; rather, it's a standard feature of coalition politics in Israel regardless of the individual or party forming the coalition.

All these errors erode the credibility of

the *Times* coverage. If the newspaper can't get basic factual points right in a front-page news article, why should readers believe the rest of the newspaper's narrative?

What's more, such factual errors aren't rare exceptions, but are typical of *Times* coverage of Israel and Jewish matters. Some previous examples include what the Israeli consul general in New York, Dani Dayan, called the "correction of the year," about Palestinian payments to families of terrorists; confusing Orthodox and Conservative Judaism; and a seven-sentence, "epic" correction of a hatchet-job profile of a prominent critic of the Iran nuclear deal.

Jewish Groups, Israeli Officials Welcome UK's Hezbollah Ban

The British government's declaration on Monday that it would blacklist all wings of Hezbollah as a terrorist organization was warmly welcomed by Jewish groups in the UK and around the world, as well as by Israeli officials.

In a joint statement, Marie van der Zyl, president of the Board of Deputies of British Jews, Jonathan Goldstein, chair of the Jewish Leadership Council, and David Delew, chief executive of the Community Security Trust, said, "The Jewish community, including our organizations and leading community newspapers, have long led the call for this ban."

"The previously held false distinction, between the 'political' and 'military' wings, was denied by even the group's leader Hassan Nasrallah, who said that, 'The story of military wing and political wing is the work of the British," they added. "This has led to a situation where Hezbollah supporters were free to parade the flags of this antisemitic terrorist organization on the streets of London. Following today's announcement, we call on all of the relevant authorities to ensure that this will no longer be tolerated."

"The government, and in particular the home secretary and the foreign secretary, have our thanks for their leadership on this issue and we encourage other countries to follow suit," they concluded. "We would hope that all political parties would back this measure to secure our community and the rest of the UK from the murderous, antisemitic terrorists of Hezbollah. It is customary for terrorism proscriptions to be supported on a cross-party basis and we call on MPs and peers to back the motions in both Houses of Parliament this week."

World Jewish Congress CEO & Executive Vice President Robert Singer said, "It is

Rouhani — a champion of the nuclear deal — has still not formally accepted Zarif's resignation. And the majority of lawmakers sent Rouhani a letter asking him to keep Zarif on, the *Islamic Republic News Agency* (*IRNA*) reported.

Rouhani has not responded publicly to the letter from lawmakers, but piled praise on Zarif on Tuesday, saying the minister had been at the forefront of the fight against America, *IRNA* said.

Unconfirmed media reports indicated

clear that there is no distinction between the so-called political and military wings of Hezbollah, which has for many years engaged in and promoted terrorist activity around the world. It is absolutely right that the UK no longer makes such a distinction and has recognized Hezbollah for exactly what it is: a terrorist organization. We hope that other countries, as well as the United Nations, the European Union and the Organization of American States will follow this lead and also proscribe Hezbollah outright."

The American Jewish Committee and Anti-Defamation League issued similar statements.

Israeli Public Security and Strategic Affairs Minister Gilad Erdan tweeted, "Thank you to the UK and my friend @sajidjavid for deciding to designate all of #Hezbollah as a terrorist group. All who truly wish to combat terror must reject the fake distinction between "military" & "political" wings. Now is the time for the #EU to follow suit! @FedericaMog"

Israeli Ambassador to the UN Danny Danon stated, "The separation between the political and armed wings is a false and artificial separation because both are controlled and supported by Iran, and enable the organization to continue to raise funds on European soil. We will continue to lead the struggle for the Security Council to recognize Hezbollah as a terrorist organization, and mobilize the international community against it as it serves as an arm of Iran to spread Tehran's aggression."

Zarif resigned because he had not been informed about Syrian President Bashar al-Assad's visit to Tehran on Monday.

In another apparent olive branch, Rouhani said Assad had specifically thanked Iran's Foreign Ministry during his visit.

Zarif was quoted as condemning "factional fighting" in a newspaper interview published on Tuesday — suggesting political tensions may have played a part in his decision.

The *Fars* news agency reported that the interview had taken place last week, before Zarif's resignation.

EU Presidency Candidate Calls for Europe-Wide 'Pact' to Combat Rising Antisemitism

One of the leading candidates to be the next president of the European Commission of the EU has called for a continent-wide pact to combat antisemitism, asserting that the "continuing advance" of anti-Jewish feeling on the continent "should be a wakeup call for us all."

Manfred Weber — a German politician who leads the center-right European People's Party, the largest parliamentary grouping in the European Parliament — told the German news outlet Die Welt on Sunday that he would launch an initiative to "send a clear message that antisemitism has no place in Europe."

Alongside Socialist candidate Frans Timmermans, Weber is one of the two frontrunners tipped to succeed current incumbent Jean-Claude Juncker as president of the European Commission — the executive branch of the European Union — in elections this May that will pit nationalist "Euroskeptic" candidates against pro-EU rivals in several countries.

Weber told Die Welt that if he were elected to the president's post, he intended to form a European "pact" against antisemitism. The pact would include increased legal pressure on internet platforms and social media accounts to "stop the dissemination of antisemitic ideas," Weber said. He added that the pact would require a "common definition of antisemitism valid throughout Europe." Last June, the European Parliament voted for a resolution that called on all the EU's 28 member states

The next maneuver is planned for Monday night. Beresheet is currently on its first orbit of Earth after successfully launching on Thursday on the back of a SpaceX rocket, but its journey to the moon may not be all smooth sailing: a Friday update from its operators stated the craft's star-based navigation system is experiencing problems due to glare from the sun.

Beresheet — "Genesis" in Hebrew — is a private venture by Israeli non-profit SpaceIL, in partnership with Israeli state-owned defense contractor IAI. The project, which cost around \$100 million, was funded mostly from donations. Around \$40 million of the sum came from philanthropist and businessman Morris Kahn, who is also SpaceIL's president. Initially founded to compete in Google's to adopt the International Holocaust Remembrance Alliance's "working definition of antisemitism" — so far. 11 have done so.

Weber's comments came as several fellow German politicians called over the weekend for stronger action against antisemitism. Earlier this month, government statistics showed a 60 percent surge in violent attacks against Jews in Germany during 2018, in keeping with a Europe-wide trend that also saw a sharp increase in attacks on Jews in France and the UK over the last 12 months.

Two of the politicians quoted by Die Welt argued that the boycott, divestment and sanctions (BDS) campaign targeting Israel should be regarded as unambiguously antisemitic.

Karin Prien — minister of education in Germany's northern state of Schleswig-Holstein — stated that the term "BDS" was a modern version of Nazi-era slogan, "Kauft nicht bei Juden" ("Do not buy from Jews"). Condemning the aim of the BDS campaign that "the Jewish state should be economically, culturally and politically isolated," Prien denounced its "perfidious message that wants to delegitimize the only Jewish state in the world."

Die Welt quoted Christian Lindner, the leader of the liberal FDP party, calling for a clearer understanding of the overlap between anti-Zionism and antisemitism.

"No NGOs that demand a boycott of Israeli products or enterprises, either domestically or abroad, should be financed with state funds," Lindner emphasized.

Israel's Beresheet Spacecraft Advances on Its Lunar Journey

SpaceIL and Israel Aerospace Industries (IAI) successfully completed Israeli spacecraft Beresheet's first maneuver in orbit, taking into account the limitations previously identified with the vehicle's star navigation system. The 30-seconds maneuver, which engaged Beresheet's main engine for the first time, was completed 69,400 kilometers away from Earth.

Israel Ranked 10th Healthiest Country in the World

Israel has been listed as the 10th healthiest country in the world, according to the 2019 edition of the Bloomberg Healthiest Country Index.

The list ranked 169 economies according to factors contributing to overall health.

Though Israel dropped from the ninth slot in 2018, it was still among the top 10. Spain jumped several spots to become listed as the healthiest country in the world-one spot above Italv.

Iceland came in third place, Japan fourth, Switzerland fifth, Sweden sixth, Australia

seventh, Singapore eighth and Norway ninth. The United States came in 35th place.

Factors included life expectancy, tobacco use and obesity, as well as access to clean water and proper sanitation.

Researchers heralded the Mediterranean diet in Spain and Italy for its contribution to overall health.

In 2018, Bloomberg ranked Israel as having the sixth most efficient health-care system in the world, below Hong Kong, Singapore, Spain, Italy and South Korea. The United States ranked 54th place in that survey, tied with Azerbaijan.

Swastikas, Antisemitic Graffiti Found in Amsterdam Ahead of **Sports Match**

Swastikas and antisemitic graffiti have been scrawled on buildings in Amsterdam on Friday.

Fans of the soccer club ADO The Hague are suspected of carrying out the attack in a targeted message ahead of a Sunday match against rival Amsterdam club Ajax, who historically refer to themselves as the "Jews." Ajax supporters like to refer to themselves as the Jews, or the super Jews, a nickname that has often led to antisemitic chanting by opposing fans.

Among the vandalized structures was the statue De Dokwerker, which commemorates a general strike in 1941 to protest the rounding up of Jews by the Nazi occupiers of the city during World War II.

Elsewhere in the city, walls have been sprayed with swastikas and with the letters JHK, or "Jews have cancer." The graffiti also stated that 020 is not welcome in 070-a reference to the two cities' postal codes.

"As a club, we emphatically oppose these incomprehensible actions. It is disrespectful and sad," wrote Mattijs Manders, general manager of ADO The Hague, on the club's website.

The World Jewish Congress condemned the vandalism and called for punitive measures. "The vandalism carried out overnight in

Amsterdam deserves unequivocal condemnation by both authorities and society at large. "We deeply appreciate the ADO football club's immediate rejection and condemnation of this desecration and urge its leadership to take punitive measures against any supporters found to have been involved in this outrageous act, if it indeed emerges that this was the case," he added.

Singer said "the World Jewish Congress will reach out to the Dutch Jewish community and to the football club's leadership to engage them in the educational projects we have already developed with other football clubs."

Left-Wing Jewish Group Pickets University of Texas Chabad During Shabbat Services, Citing IDF Event

A chapter of a left-wing group that aims to decrease Jewish American support for Israel staged a protest outside the University of Texas Chabad House on Saturday, while congregants gathered to participate in morning prayers, the community's rabbi said.

Less than ten people affiliated with the Austin chapter of IfNotNow stood outside the Chabad House — which was set to host a lecture with a former Israeli soldier that afternoon — with signs including "Occupation is not moral," and "My gramma was a survivor, too. Not in my name."

In a statement shared on Sunday and subsequently disputed by IfNotNow, Rabbi Zev Johnson said the group had blocked "the entry and exit to Chabad House," and "shockingly ... spoke to my young children and gave them flyers."

He also accused protesters of taking photos and videos of individuals, including his children — "something which is

traditionally prohibited on Shabbat for religious reasons." Johnson quoted his 4-year-old daughter asking, "What are those people doing outside? They just asked me to leave Chabad and come sing with them Daddy."

He added that his 7-year-old daughter and 10-year-old son were also given a flyer by the protesters, and that they asked him, "Why are these people doing this to us in the middle of Shabbat morning services?"

"It's absolutely unacceptable and unethical that these protesters targeted my children," Johnson argued. "I, as an adult, truly enjoy good conversation with mutual respect, but for [protesters] to engage young children is plain wrong."

Ex-IDF soldier Leibel Mangel — whose talk at the Chabad House touched on his grandfather's experiences in the Holocaust and his own military past — likewise said on Twitter on Sunday that he personally witnessed the children being targeted, "as did everyone in attendance."

Yet IfNotNow Austin rejected the rabbi's account, noting in a statement later on Sunday that the protesters "chose to remain at a respectful distance" because of Shabbat, and were not targeting the prayer services. They rebuffed accusations of

NYC Health Department Urges Orthodox Travelers to Israel to Vaccinate for Measles

The New York City Department of Health and Mental Hygiene is urging all Orthodox Jews who plan to make a trip to Israel to vaccinate their children against the measles virus.

An outbreak of measles believed to be caused by an unvaccinated child who contracted the disease in Israel led to 90 confirmed cases in Brooklyn, NY, between October and February 2019, a high number attributed to low vaccination rates in the ultra-Orthodox community.

The neighborhoods primarily affected were Borough Park and Williamsburg, which had 40 cases each.

Israel's measles outbreak led to the death of two people, including an 18-month-old infant in 2018.

impeding access to the building or recording and photographing any attendees, including the rabbi's children, writing, "Not one of these claims is true."

While Johnson called the event with Mangel "a thoughtful and meaningful conversation ... with no politics but plenty of love and mutual respect," IfNotNow described it as "promoting and justifying violence against occupied Palestinians," and rejected characterizations that it is a marginal group in the Jewish community.

"It's a sad day when an ex-IDF soldier has a platform for propaganda inside a communal space on Shabbat, and a group of Jews outside singing songs like 'Lo Yisa Goy' ('A nation shall not raise a sword against a nation and they shall not learn any more war' Isaiah 2:4) and 'Olam Chesed Yibaneh' ('we will build this world with love') is considered 'fringe,"

In an earlier statement, IfNotNow Austin invited UT Chabad "to join us in opposing the occupation," and alleged that "Jews have survived in diaspora for thousands of years, largely through solidarity with other oppressed groups."

AntiSemites in the United States Congress



There is a lot of talk these days about white privilege and it is true that white Americans do enjoy many advantages. However, some of the people who are most vocal in making accusations of this type have created a new type of privilege for minorities which is used to shield them from criticism for their own prejudices. We see this often in the willingness of liberals to give a pass or, worse, endorse anti-Semitic views.

I can understand and agree with the outrage expressed toward the governor of Virginia for his insensitivity and tone-deafness when confronted with his inappropriate behavior. What we should not abide is the silence of Democrats to antiSemites in their midst, just as we should not abide Republicans who might turn a blind eye to white supremacists.

Consider Congresswomen Ilhan Omar and Rashida Tlaib. Both women are advocates of the anti-Semitic boycott, divestment and sanctions (BDS) movement. Like some BDS proponents, they portray it as a human rights campaign, but they have been told by their Jewish constituents, among others, that the goal is the destruction of Israel. This is why 134 international Jewish organizations from across the political and religious spectrum signed onto a statement opposing BDS.

Their support for BDS alone should merit censure, but both have made incendiary remarks that cannot be excused as "legitimate criticism of Israel." Omar has repeated the slur comparing Israel to Afrikaner South Africa and, in 2012, tweeted: "Israel has hypnotized the world, may Allah awaken the people and help them see the evil doings of Israel." As New York Times columnist Bari Weiss noted, "The conspiracy theory of the Jews as the hypnotic conspirator, the duplicitous manipulator, the sinister puppeteer is one with ancient roots and a bloody history."

On her first day in office, Tlaib displayed a map with a note posted over Israel that reads "Palestine." She also expressed the popular anti-Semitic canard that Jews have dual loyalty and care more about Israel than the United States. Referring to supporters of anti-boycott legislation, she said, "They forgot what country they represent," Tlaib said in a tweet. "This is the U.S. where boycotting is a right & part of our historical fight for freedom & equality." Later, she claimed the comments were not directed at Jewish members.

Both women are shockingly ignorant when they talk about Israel. Omar, for example, said, "When I see Israel institute a law that recognizes it as a Jewish state and does not recognize the other religions that are living in it, and we still uphold it as a democracy in the Middle East, I almost chuckle, because I know that if we see that in any other society we would criticize it, we would call it out."

Israel is the only country in the Middle East that guarantees freedom of religion. She supports Palestinian rights but does not seem to care that the leaders of the Palestinian Authority deny their people not only religious freedom, but freedom of speech, press, and assembly. It bothers her that Israel is the one Jewish state in the world, but does not "call out" the nations where Islam is the state religion.

As Weiss rightly observed, "those who call themselves anti-Zionists usually insist they are not antiSemites. But I struggle to see what else to call an ideology that seeks to eradicate only one state in the world – the one that happens to be the Jewish one – while emphatically insisting on the rights of selfdetermination for every other minority."

As in the Northam case, a bipartisan uproar was heard when another white male, Steve King, made outrageously bigoted remarks. The entire House censured him and the Republicans went further by stripping him of his committee assignments. Contrast that with the silence of most Democrats following the anti-Semitic statements by Omar and Tlaib. It took Omar writing that Jews and AIPAC buy politicians before we heard any strong condemnation of her words.

Democrats also took an additional step – they gave both women assignments on key committees and defended them and have yet to rescind them.

House Democratic Caucus chairman Hakeem Jeffries said, "I've found those two new freshmen members to be thoughtful colleagues on a wide variety of issues." House Majority Leader Steny Hoyer said, "I don't accept the premise" that the members are anti-Semitic.

It was disconcerting for Speaker Pelosi to put Omar on the Foreign Affairs Committee where she will now have a platform to attack Israel whenever Middle East policy is discussed. Omar and Tlaib are both out of step with the bipartisan consensus on the importance of the U.S.-Israel relationship and it boggles the mind that Omar would be put in a position to undermine it.

Democratic friends of Israel try to make us feel better by saying they are just two members out of the entire Congress who support BDS. I agree. But consider what Rep. Lee Zeldin said: "Instead of the Dems supporting Israel & combatting BDS & anti-Semitism on college campuses & elsewhere, they're now empowering it."

Being a minority does not excuse inappropriate behavior whether it be racist, homophobic, sexist or anti-Semitic. We have seen this double standard repeatedly on college campuses where there is no such thing as free speech when it comes to criticism of minorities; any speech or behavior that the minorities consider inappropriate is dealt with severely. When Jews, or Israel as a euphemism for Jews, are criticized, administrations defend the free speech rights of the antiSemites.

The tacit acceptance of the views of Omar and Tlaib are indicative of a growing normalization of anti-Semitism. Outside of college campuses, anti-Semitism has been almost universally seen as taboo in America. Today, however, critics of Israel increasingly feel impunity. They assert freedom of speech "for me but not for thee" and accuse those who challenge them of McCarthyism. Now major Christian denominations, leaders of the women's march, and elected officials openly advocate the anti-Semitic boycott against Israel. Public figures not only refuse to denounce the rabid anti-Semitism of Louis Farrakhan, they meet with him and court his favor.

I don't know if it is just base politics or this new minority privilege that has prevented the critics of Gov. Northam and Rep. King from being equally vocal in denouncing the statements of Omar and Tlaib.

Politically. they are popular because they are young, outspoken and represent the far

left segment of the party. There is also concern that criticizing them would be seen as being anti-Muslim when, of course, that is preposterous. As an orthodox Jew I am thrilled that observant Muslim women are being elected to high government office. It is their hatred of Israel to which I am adamantly opposed.

Pelosi was apparently afraid to answer questions about her decision to put Omar on the Foreign Affairs Committee or her refusal to take her off after her AIPAC comment. Rep. Zeldin, a Republican Jewish male, got a taste of what any critics are likely to experience when Omar accused him of "islamophobia" and said, "Don't mind him, he is just waking up to the reality of having Muslim women as colleagues who know how to stand up to bullies!"

She laid down a marker that anyone who tries to criticize her will mediately be demonized. Both women seem willing to use minority privilege as shields against criticism.

Democrats cannot be intimidated and should not hesitate to condemn the statements by Omar and Tlaib. Furthermore, If Omar makes any additional anti-Semitic remarks she should be removed from her committee assignments. A good first step would be to adopt the resolution introduced by Zeldin rejecting anti-Israel and anti-Semitic hatred in the United States and around the world.

Democrats must show courage if they intend to brand themselves in 2020 as the party of tolerance that fights bigotry in all its forms. It would be a tragedy for the party, the Jewish people, and the country if they follow the example of universities and exempt Jew-hatred.

BBC Distorts the Reality of Life in Hebron



A flashy new feature on the *BBC* website, entitled "Hebron: One street, two sides," takes one of the most complex places in the Israeli-Palestinian conflict and creates a spectacularly misleading and one-sided narrative.

The feature, which seems to be heavily influenced by the Breaking the Silence organization and Palestinian talking points, repeatedly allows the Palestinian subjects to make unsubstantiated claims unopposed, while under-representing the Israeli side of

e story.

The presentation starts with a screen describing Hebron as "the only Jewish settlement ... in the middle of a Palestinian urban centre." This is only half the story. In reality, Hebron has a Jewish history dating back millennia. Despite facing centuries of persecution, discrimination, and massacres in the city under Islamic and Christian control, the Jewish community has always come back and re-established itself.

The text continues, telling readers that "There have been 128 attacks carried out by Palestinians in Hebron and its surroundings 2015-18," without making clear that many of these attacks included murders and attempted murders of civilians, with one particularly gruesome attack on a 13-year-old Israeli child sleeping in her bed, for example. The interactive website itself features nine video clips from a two-part *BBC* documentary that first aired in August 2018. Of the nine clips, only two are sympathetic towards the local Jewish community, while the other seven are severely critical of the Jewish community, or sympathetic with the Arab residents of the city.

Four of the nine video clips show video footage from "anti-occupation" organizations, and the Elor Azaria incident is shown on two separate videos. However, no video footage is taken from the Jewish community or pro-Israel organizations showing footage of shootings, stabbing attacks, or riots. The *BBC* feature promises to show two narratives, but instead shows the Palestinian perspective far more than the Israeli perspective.

Even when speaking to Israeli sources, the videos betray a deep-seated bias. While the Palestinians interviewed uniformly criticize Israel, the Israelis shown do not uniformly support Israel. This creates a net effect of criticizing Israel and playing down the effects and seriousness of terrorism.

Two videos in particular stand out. One, which also serves as the introductory segment in the accompanying two-part documentary, involves footage of an Israeli resident of Hebron climbing up to the roof of a building in order to remove a Palestinian flag.

That this individual gets himself caught up in razor wire and has to be rescued from his predicament while arguing his own political perspective is clearly damaging to Israel, and paints the Jewish side in negative terms.

But is this video relevant? Is it recent? No. The video was actually originally posted on the YouTube channel of the Israeli non-governmental organization B'Tselem on March 14, 2014.

Nevertheless, The *BBC* fails to acknowledge that the footage is nearly 5 years old, thus creating the impression that the incident took place recently. This displays a lack of transparency, and is simply dishonest journalism.

Breaking the Silence is a highly politicized organization that collects anonymous testimonies of Israeli soldiers regarding alleged and often unsubstantiated misdemeanors or "war crimes," which it frequently presents to foreign audiences as a means of fighting Israel's "occupation."

In the documentary, Breaking the Silence spokesperson Dean Issacharoff (more about *Continued on Page A7*

Can Israel Defeat Hamas Without Toppling It?

Despite its radical Islamist ideology and long-term commitment to Israel's destruction, Hamas in the Gaza Strip is — for now — avoiding high intensity armed conflict.

Hamas' leader, Yahya Sinwar, has expressed an awareness of the futility of a new war with Israel at this time. Instead, he is focused on other goals: ending the organization's regional isolation, strengthening its iron grip on Gaza, and avoiding an economic meltdown in the Strip, which could endanger his regime.

Hamas is relying on low intensity pressure tactics, such as weekly border rioting, to promote these goals.

It is also actively trying to set up terrorism cells throughout the West Bank and plot mass casualty attacks, which the Shin Bet intelligence agency prevents to a very large degree. Hamas' object is to weaken its arch West Bank rival, the Palestinian Authority (PA), and promote the cause of jihadist violence against Israel — and do all this without leading a trail of fire back to Gaza.

The Gaza-Israel border violence that Hamas has fomented for nearly a year represents a calculated high-risk approach. It is designed to apply pressure on Jerusalem and Cairo to ease security restrictions on Gaza, without allowing the situation to deteriorate into a new war.

Hamas' attempts to reconcile with the PA in Ramallah. which holds the kev to budget

him and his attempts to smear Israel here) is captured making the claim that

[A]s a soldier, you don't need a warrant to enter a Palestinian's house. You just decide that you're going to enter it.

HonestReporting contacted over a dozen former combat and combat support soldiers who served in Hebron. One of them, Amots Muller, even served in Issacharoff's battalion (Nahal 932) at the same time. Some served as many as 10 years ago, while others only left Hebron a few months ago.

All stridently denied Issacharoff's claim, with many calling it "a lie." Repeatedly, and independently, the former soldiers reported that soldiers can only enter a Palestinian house with clearance from higher up the chain of command. (Some said that permission is granted from the battalion commander, while others said it is given by the company commander.) The soldiers uniformly stated that this holds true unless there's an immediate operational need, such as coming under fire from a terrorist. In such cases, soldiers can take initiative but even then the activity would need to be coordinated and not done on a whim.

Coincidentally, a number of the soldiers reported being the targets of Palestinian attacks, with one recounting how a brick thrown off a nearby roof flew past his head, while another said that a Palestinian tried to stab him. Throughout the series, not one soldier or former soldier was interviewed about the attacks that they have faced.

One former soldier, Mor Shpaier, who served in 2017 in the Givati Brigade, told HonestReporting:

Let me tell you that the reality in Hebron

allocations for Gaza, have failed, and the group is now engaging with Israel and Egypt to rescue Gaza's economy.

A shared Israeli-Hamas interest in preventing an economic collapse of Gaza has led to regular injections of Qatari cash, a development that has politically damaged Israeli Prime Minister Benjamin Netanyahu. It has also led to some criticism of Hamas by Gazans, who ask whether the border violence and the casualties it causes are all just for the sake of Qatari money.

At the same time, Hamas, together with Palestinian Islamic Jihad (PIJ), the secondlargest armed faction in Gaza, has embarked on an ambitious military build-up program involving the domestic production of some 20,000 surface-to-surface rockets, the digging of a network of combat tunnels crisscrossing Gaza, and intensive war training for armed Gazan battalions.

The result is an inherently unstable Gaza arena that could rapidly shift from low-level confrontation to high-intensity armed conflict, sparked by any number of localized tactical incidents.

Therefore, now is the crucial time for Israel to consider the end objective of any future armed conflict in Gaza, despite the lack of any will on Jerusalem's part to enter into one.

In recent years, the IDF Southern Command, which is responsible for much of the war planning for Gaza, has identified a long-term truce as the best of the bad options for Israel. This is based on the understanding that an Israeli invasion of Gaza and subsequent destruction of the Hamas regime would leave Israel in the unenviable position of being directly in charge of some two million mostly hostile Gazans. This could lead to an open-

is more complex than that of any other army in the world ... the window of opportunity for you to err and hurt a civilian, a Palestinian, or yourself is 24/7.

Numerous other ex-soldiers reported that Israeli soldiers could enter a Palestinian home spontaneously while in pursuit of a suspect, or if a soldier came under fire and needed cover. However, all made clear that this was the exception rather than the rule.

Another Givati infantry soldier, Itamar Dayani, said:

[E]ntering a Palestinian home is defined in IDF terminology as a planned mission, and even the smallest of these requires combat planning and the permission of the company commander. ... [I]t would be an operational mistake to enter a home without advance preparation and permission.

Itamar served as a soldier and commander in Hebron over two stints: for four months in 2015, and another four months in 2017.

Interestingly, another one of the videos taken from the documentary shows Hebron Jewish community deputy spokesman Yishai Fleisher make a claim that Jews can only enter 3% of Hebron. On the website, a text then appears challenging his assertion.

Why is it that the Jewish community's spokesman is challenged, but Breaking the Silence's egregious statement is not?

Why did the *BBC* give a platform to a political lobby such as Breaking the Silence, without subjecting their claims to even the most basic of fact-checking? And why was an unsubstantiated and seemingly false statement allowed to pass without any examination or comment?

ended and draining military occupation.

It would be extremely difficult to find alternative rulers for Gaza, with the PA likely unwilling or unable to "ride into Gaza on Israeli tanks" and assume a governing role. The PA would risk its legitimacy and be exposed to even harsher criticism from its Islamist rivals, who are always keen to depict it as a collaborator with Israel.

And even if the PA was willing to take over Gaza at some point, it remains unclear whether it is capable of governing the Strip, as the 2007 Hamas armed coup already demonstrated.

As a result, any post-war Israeli presence in Gaza could drag on for years, and prove costly in both blood and treasure. Alternatively, Israel could demolish the Hamas regime and leave Gaza, putting it on a fast track to a "Somalia model" of anarchy and violence.

Under that scenario, no clear ruling party would emerge to fill the vacuum in post-Hamas Gaza. Multiple jihadist armed gangs that lack a central ruling structure would appear, and Israel would be unable to project its military might to any single "return address" in Gaza. This would result in a loss of Israel's deterrent force on Gaza to keep the region calm. This scenario would be considerably worse than the current status quo.

But a third option, in between the options of leaving Gaza as it is and toppling Hamas, may exist.

Under this third scenario, the IDF would decimate Hamas' military wing in any future conflict, but leave its political wing and police force in place. This would enable a rapid Israeli exit after a war, but avoid a Somalia-like fate for Gaza, with its destructive implications for both Israelis and Gazans.

The question of whether Israel has the option of leaving Hamas' police force and civilian government administration in place in a future war rests largely on how such entities are defined.

On the one hand, Hamas' police force is an intrinsic support system for Gaza's terroristguerrilla forces. On the other, the police and domestic security units play a genuine role in keeping order in Hamastan. Such forces have been used to repress ISIS-affiliated cells that challenge Hamas' rule.

In 2008, in response to an onslaught of Hamas rockets, Israel launched Operation Cast Lead with a surprise air attack. Among the over 100 targets that it destroyed, the Israel Air Force bombed 24 Hamas police stations, including Gaza City Police headquarters, where a cadet graduation ceremony was underway. An estimated 40 people, including several dozen police cadets, were killed.

Clearly, in that conflict, Israel identified the Hamas police force as an intrinsic part of the Hamas regime's terrorist assets, and a legitimate enemy target.

Eleven years later, this thinking may have changed somewhat. The reason is due not to any change in the close ties between the domestic armed units of Gaza and the Hamas military wing, but rather, to the fact that Hamas' ability to continue to rule Gaza

after a future war might be in Israel's interest. Compared to the alternative scenarios of indefinite occupation or the "Somalia scenario," a weakened Hamas might be the best and most realistic option.

To be sure, Hamas continues to use its police force to support its terrorist-guerrilla army. The organization uses the Gazan naval police, for example, as a cover for its build-up of naval commando attack cells. For this reason, Israel has repeatedly struck naval police sites in Gaza, including in May of last year during an escalation.

But if the option of launching a powerful future offensive in response to a sudden escalation is to include the possibility of a rapid Israeli exit, a substantial part of Hamas' ability to police and administer Gaza may need to be kept intact.

The IDF's official strategy calls for any future high intensity war to be based on a "rapid, deadly ground offensive towards targets perceived by the enemy as being of value." It also calls for overwhelming firepower in support of such a maneuver, largely based on air power and guided by high-quality intelligence.

If Israel focuses these offensive capabilities on the Izz-ad-Din al-Qassam Brigades, but not on the rest of the Hamas regime, it might be possible for Jerusalem to go beyond the objectives of past operations — which stopped at the goal of deterring Hamas and securing a period of calm for the South. It could significantly degrade Hamas' military wing and still leave a Hamas version of the PA behind.

It remains to be seen whether the Israeli defense establishment and cabinet will adopt such an offensive plan in any future conflict. This option would leave the door open for Hamas' military wing to eventually rebuild itself, though that could take many years if sufficient damage is inflicted on its core command structure and armed fighting capability.

Hamas, for its part, is keen to preserve both its "government project" and its armed wing, and has pursued brinkmanship with Israel based on the understanding that Jerusalem is deterred by the idea of toppling the Islamist regime.

Placing a credible threat on just the military wing could go some way towards replenishing Israeli deterrence.

Kansas Should Strengthen Bonds With Israel

Last week, I requested the introduction of legislation that would give Kansas the option of investing in Israel Bonds. While I have long been a supporter of Israel, as Kansas State Treasurer, my primary responsibility is to put the needs of Kansas first. Moving into the world of foreign investing would be a new endeavor for the state, and Israel Bonds could be an excellent entry point into the marketplace — not to mention the perfect opportunity to both show support for Israel and strengthen a long-time trade relationship with a nation that is flourishing.

Under the proposal, the Kansas Pooled Money Investment Board (PMIB) would be given the option of investing up to 2 percent of the state's idle funds in Israel Bonds. The goal is not to mandate the board to act, but to give them the option if the investment makes sense for Kansas.

Current law only allows the state's portfolio

managers to invest in securities issued by the United States and its agencies. When looking at long-term investments, Israel Bonds often see a higher yield than US Treasuries, and have never defaulted on interest and principal payments. This kind of investment option should be available to our state, and could certainly be a good thing for Kansas taxpayers.

The Kansas Legislature has already shown its support of Israel through legislation approved in both 2017 and 2018, which requires certain state contractors to confirm that they are not actively engaging in a boycott of Israel. Receiving wide, bipartisan approval, that legislation sent a strong message that our state wants to further its collaboration with Israel. Now is the time to take the next step.

Israel is often featured on the nightly news with a focus on some geo-political conflict, or images of those supporting the anti-Israeli "BDS movement," which seeks to "Boycott, Divest, and Sanction" the only democracy in the Middle East. What the news is not showcasing is what the world should know about the State of Israel — that despite these challenges, it continues to grow with an economy that happens to be one of the world's most vibrant.

Earning the name "Start-Up Nation," Israel behind the United States — is home to the highest number of start-up companies in the world, ranking as the third-highest country with the most NASDAQ listed companies. Outside of Silicon Valley, Israel is home to more tech companies than anywhere else.

When looking at Israel's relationship with Kansas specifically, roughly 60 Kansas companies have already begun doing business with Israel, including Aerospace Controls Corporation, Garmin Communications, and *Continued on Page A12*

Abortion and Jewish Law

New York's Reproductive Health Act was signed into law by Democratic governor Andrew Cuomo on January 22, to a standing ovation and acclaim by state legislators. This new law allows abortion on the basis of "reasonable and good faith professional judgment based on the facts of the patient's case" when "the patient is within twenty-four weeks from the commencement of pregnancy, or there is an absence of fetal viability, or the abortion is necessary to protect the patient's life or health."

The law allows women to have an abortion up to 24 weeks without question. After 24 weeks, such decisions must be made with a determination that there is an "absence of fetal viability" or that the procedure is "necessary to protect the patient's life or health." That determination must be made by a "health care practitioner licensed, certified, or authorized" under state law "acting within his or her lawful scope of practice." New York's new law does not explicitly define "health."

The context was, and is, a fear that a conservative Supreme Court might revoke or limit the famous Roe v. Wade decision to allow abortions. Although many people believe there is no chance of that decision being overturned, the headlong rush to remove as many restrictions as possible is seen as a crucial plank in the Democratic left-wing and secular electorate.

I agree with the idea of minimum state interference in private lives and choices. I believe people have the right to make their own decisions regardless of sex or inclination. With sadness, I recognize that there can be valid reasons for abortions that I do not always consider to be ethically wrong under Jewish law. However, I do not agree that someone can have an abortion on demand, and right up until birth, simply because the mother might not feel well or for trivial reasons. And if that is an exaggerated description of the new situation in New York and similar states, the fact is that the new law allows this in practice.

And now to Jewish law and ethics.

According to the Talmud, the fetus is recognized as such only after 40 days from conception. Before that, it is regarded as liquid and has no legal status. Interestingly, the child's heartbeat can be detected around that time. Therefore, any act to end pregnancy during that period does not offend Jewish law. After that time, only a threat to the life of the mother allows for an abortion, on the grounds of self-defense. The fetus counts as a limb of the mother, which may be removed to save her. Once most of the body has emerged, the fetus has the same status as any other human being.

In recent years, many rabbis have allowed abortions of fetuses that are unviable (i.e., they would not be able to survive unaided outside the womb). Some have also allowed abortions where the mental state of the mother is so severe that carrying to full term might endanger her mental stability.

But waiting 24 weeks or later for an abortion of choice contravenes Jewish law.

All the New York law now requires is that a single medically-qualified individual agrees, and then one can abort all the way up to full term.

There is a surprising anomaly in Jewish law. On abortion, Jewish law is much more open and flexible than many other religions and ideologies. But according to the Talmud, all non-Jews have a moral obligation to abide by the Seven Commandments given to Noah. One of them is not to murder. Jewish law interprets infanticide as murder. But whereas Torah law is relatively lenient for Jews, it is much stricter for non-Jews — where any kind of abortion is forbidden except in cases of the mother's actual life being in danger. Why is it stricter for non-Jews?

The reason most often given is that, since morally advanced societies are expected to have a heightened sense of the sanctity of life, pagan societies routinely were guilty of infanticide and had less regard for human life. They needed more limitations, safeguards, and protections.

I used to find this offensive to the many non-Jews I knew who had a very highly-developed sense of morality. But now I wonder if I was wrong. It seems that today's dominant view is to not care very much about what happens to unborn children. Many apparently moral men and women are prepared to condone cutting a living organism out of a mother's womb in the name of intersectionality and political correctness.

Although opponents of abortion often exaggerate and go too far the other way, there is enough evidence of babies born viable and left to die, if not actually murdered, to make me wonder what kind of morality the Western world subscribes to.

There is a fascinating debate in the Talmud tractate Sanhedrin between Antoninus and Rebi Yehudah the Prince (the head of the Jewish



community some 1800 years ago in the land of Israel). We don't know whether Antoninus was a real Roman or a symbolic one. Some say he was Marcus Aurelius, who was that rare phenomenon of a sensitive and wise emperor. Others say he was a Roman spokesman for Christianity. Either way, the two men actually consorted and debated in a civilized manner.

The question is: when does the soul enter the human body? Antoninus says at conception. Rebi Yehuda Hanassi says only when the fetus is fully formed. It looks like this debate was as relevant then as it is now. Antoninus was the representative of all that was morally good and caring in the non-Jewish world. In this debate, it is the Jewish spokesman who is more in tune with our modern thinking, while representing a traditional Jewish perspective.

I was educated to think that we tend to become more civilized over time. But that's not necessarily so. The abortion issue in the US today illustrates everything the religious right claims — that society has gone mad and lost its moral bearings.

The Beauty of Holiness or the Holiness of Beauty



In Ki Tissa and in Vayakhel we encounter the figure of Betzalel, a rare type in the Hebrew Bible - the artist, the craftsman, the shaper of beauty in the service of God, the man who, together with Oholiab, fashioned the articles associated with the Tabernacle. Judaism - in sharp contrast to ancient Greece - did not cherish the visual arts. The reason is clear. The biblical prohibition against graven images associates them with idolatry. Historically, images, fetishes, icons and statues were linked in the ancient world with pagan religious practices. The idea that one might worship "the work of men's hands" was anathema to biblical faith.

More generally, Judaism is a culture of the ear, not the eye. As a religion of the invisible God, it choly, he should cure it by listening to songs and various kinds of melodies, by walking in gardens and fine buildings, by sitting before beautiful forms, and by things like this which delight the soul and make the disturbance of melancholy disappear from it. In all this he should aim at making his body healthy, the goal of his body's health being that he attain knowledge.

The very terms in which Maimonides describes the aesthetic experience make it clear, however, that he sees art in strictly instrumental terms, as a way of relieving depression. There is no suggestion that it has value in its own right.

The strongest positive statement on art of which I am aware was made by Rabbi Abraham ha-Cohen Kook, the first Ashkenazi Chief Rabbi of (pre-State) Israel, describing his time in London during the First World War:

When I lived in London, I would visit the National Gallery,



attaches sanctity to words heard, rather than objects seen. Hence there is a generally negative attitude within Judaism towards representational art.

There are some famous illustrated manuscripts (such as the Bird's Head Haggada, Bavaria, circa 1300) in which human figures are given bird's heads to avoid representing the full human form. Art is not forbidden as such; there is a difference between three-dimensional and two-dimensional representation. As Rabbi Meir of Rothenburg (c. 1215-1293) made clear in a responsum, "There is no trespass [in illustrated books] against the biblical prohibition... illustrations are merely flat patches of colour lacking sufficient materiality [to constitute a graven image]." Indeed several ancient synagogues in Israel had quite elaborate mosaics. In general, however, art was less emphasised in Judaism than in Christian cultures in which the Hellenistic influence was strong.

Positive references to art in the rabbinic literature are rare. One exception is Maimonides, who says the following:

and the paintings that I loved the most were those of Rembrandt. opinion Rembrandt In my was a saint. When I first saw Rembrandt's paintings, they reminded me of the rabbinic statement about the creation of light. When God created the light [on the first day], it was so strong and luminous that it was possible to see from one end of the world to the other. And God feared that the wicked would make use of it. What did He do? He secreted it for the righteous in the world to come. But from time to time there are great men whom God blesses with a vision of that hidden light. I believe that Rembrandt was one of them, and the light in his paintings is that light which God created on Genesis day.

Rembrandt is known to have had a special affection for Jews. He visited them in his home town of Amsterdam, and painted them, as well as many scenes from the Hebrew Bible. I suspect that what Rabbi Kook saw in his paintings,

Guy Nattiv's Oscar Win for Short Film 'Skin' Celebrated in His Native Israel

Israeli President Reuven Rivlin congratulated Israeli filmmaker Guy Nattiv for winning the Academy Award for best live action short film on Sunday night for his film "Skin."

The 20-minute movie centers around two gangs who engage in a war after a black man smiles at a 10-year-old white boy inside a supermarket located in a blue collar town.

Nattiv, who also co-produced the film alongside his wife Jaime Ray Newman, was the first Israeli to win an Oscar in 41 years.

Rivlin on Monday took to Twitter to describe the English-language movie as "a gift to our children and grandchildren and for the future we wish for them."

He added, "Proud to be Israeli! Mazal Tov!"

In his acceptance speech, Nattiv, who was joined on stage by his wife, began by saying, "Layla tov, Israel." He then talked about his Holocaust survivor grandparents, noting, "The bigotry that they experienced in the Holocaust, we see that everywhere today in America, in Europe. And this film is about education; it's about teaching your kids a better way."

At a press conference following the ceremony, Nattiv revealed that a full-length film based on "Skin" would be released in July.

He later told Israel's Channel 12 news via video link from the award ceremony after-party that he would bring the Oscar to Israel because his movie was "half Israeli."

Knesset Speaker Yuli Edelstein also tweeted about Nattiv's Oscar win. He wrote on Monday, "Warm congratulations to Guy Nattiv on his winning an Oscar! I heard Guy speak excitedly this morning about the Israeli production and the great achievement for Israel, and we are all excited with him. Great pride!"

Israel's Transportation Minister Yisrael Katz welcomed the win, tweeting, "Guy, you made us very proud. Thank you."

Israeli Finance Minister Moshe Kahlon tweeted a message to Nattiv, saying, "You have brought great honor to us and all of Israel at the Oscar ceremony. An exciting and inspiring moment. I hope that many more Israeli children will follow in your footsteps and continue to produce quality groundbreaking cinema for us and the whole world." though, was Rembrandt's ability to convey the beauty of ordinary people. He makes no attempt (most notably in his self-portraits) to beautify or idealise his subjects. The light that shines from them is, simply, their humanity.

It was Samson Raphael Hirsch who distinguished ancient Greece from ancient Israel in terms of the contrast between aesthetics and ethics. In his comment on the verse "May God enlarge Japheth and let him dwell in the tents of Shem" (Genesis 9:27), he observes:

The stem of Japheth reached its fullest blossoming in the Greeks; that of Shem in the Hebrews, Israel, who bore and bear the name (Shem) of God through the world of nations... Japheth has ennobled the world aesthetically. Shem has enlightened it spiritually and morally.

Yet as we see from the case of Betzalel, Judaism is not indifferent to aesthetics. The concept of hiddur mitzvah, "beautifying the commandment," meant, for the sages, that we should strive to fulfil the commands in the most aesthetically pleasing way. The priestly garments were meant to be "for honour and adornment" (Exodus 28:2). The very terms applied to Betzalel – wisdom, understanding and knowledge – are applied by the book of Proverbs to God Himself as

The key to Betzalel lies in his name. It means "In the shadow of God." Betzalel's gift lay in his ability to communicate, through his work, that art is the shadow cast by God. Religious art is never "art for art's sake." Unlike secular art, it points to something beyond itself. The Tabernacle itself was a kind of microcosm of the universe, with one overriding particularity: that in it you felt the presence of something beyond – what the Torah calls "the glory of God" which "filled the Tabernacle" (Exodus 40:35).

The Greeks, and many in the Western world who inherited their tradition, believed in the holiness of beauty (Keats' "Beauty is truth, truth beauty, that is all / Ye know on earth, and all ye need to know"). Jews believed in the opposite: *hadrat kodesh*, the beauty of holiness: "Give to the Lord the glory due to His name; worship the Lord in the beauty of holiness" (Psalms 29:2). Art in Judaism always has a spiritual purpose: to make us aware of the universe as a work of art, testifying to the supreme Artist, God Himself.

It is no coincidence that the piece that attracted Shavit's mudslinging - free of rebuttal of a single fact or assertion - has been translated and thoroughly discussed by the influential Palestinian newspaper, Al-Quds Al-Arabi.

In reality, it is difficult to find national decisions — in the social, economic, political, educational, and security fields, among others — that are completely value-free and made on professional grounds alone. A medical prognosis is a strictly professional matter; public health policy decisions reflect a socioeconomic worldview and value system.

This in turn means that when former security officials justify far-reaching territorial concessions "because the preservation of certain values overrides the importance of land," they do so from a clear political vantage point. As such, they have
